Dear Ms. Crevey:

I would like to nominate Jerry Garrett, Maintenance Partner at Magnolia Court Assisted Living and Memory Care, for the 2009 ALFA Hero Award.

Jerry is one of the hardest working employees in our community and has the most physically demanding job. Not only does he keep all of our electrical, plumbing, communication, heating & cooling, cleaning, safety, and outdoor systems functioning, he is also faced with the daily requests of a large population of elderly residents and busy Employee Partners. And, in a community where memory impairment is the norm, these requests are frequently repeated multiple times, even though the task has been completed! Not only is Jerry skilled and efficient at the maintenance aspects of his job, he has a bottomless reservoir of patience, compassion and empathy for the people who live here. They need him, they depend on him, and they love him.

Magnolia Court is a beautiful community and stays that way largely because of Jerry. He cares deeply about the building and grounds and works diligently to keep everything as perfect as he can make it. Visitors always comment on the décor and the ambience here: Jerry strives constantly to make sure this lovely environment stays as attractive as it was on the day we opened!

No matter which task he is facing, Jerry stays until the job is done. I have seen him put in late hours to finish a project which, left uncompleted, could impair the comfort and or safety of our residents. Not only does he carry out his assigned duties skillfully and efficiently, he pitches in elsewhere whenever needed. He has served dinner, helped with activities, driven residents to appointments, and always wins a prize in the Halloween costume contest! Jerry's calm and dependable demeanor has helped defuse many a potentially escalating resident meltdown.

Jerry's greatest challenges (that I have observed over the past seven months I have known him) occurred with the two recent hurricane threats to our community. Not only did we experience wind damage, power outages, and equipment malfunction, we also took in several evacuees from another elder care community. We all stayed and worked many long hours, but Jerry had the responsibility for bringing in extra beds, helping transfer our evacuee guests, dealing with all the outages and equipment issues, not to mention the cleanup inside and outside afterward.

I know there must be many more stories about Jerry's hard work and extra effort that occurred before I joined Magnolia Court and probably even more that no one but Jerry knows about. However, regardless of whether or not Jerry receives the ALFA Hero Award, he is a hero to all of our residents and employees and always will be!
